

This new edition will be a faithful replica of the original, with the famous "circus cover" dust jacket and bulky paper (which is why it was initially called the Big Book). To commemorate the 75th anniversary of the historic publication of Alcoholics Anonymous in April 1939, the 2013 General Service Conference approved the creation of this facsimile edition of the first printing of the first edition. Preorders: Starting November 15, 2013."

Intergroup 2014 Budget

Article VIII, Section 3d of the Nassau Intergroup (NI) by-laws require that the Financial Review Committee "prepare the yearly budget [for the following year] for presentation at the November [Reps] meeting, so that the groups will have a month to review it before voting on it in December." This year, we will not meet that mandate, and will not have a draft 2014 budget for the Reps Meeting to consider before December.

At that time, the groups will receive a summary of NI's financial activity through the third quarter 2013, and an analysis of income and expenses line by line relative to the 2013 budget. They will also receive a recommendation from the Financial Review Committee for what seems prudent for a 2014 budget in light of the 2013 data and likely changes in 2014 to income and expenses items. That recommendation will have also been reviewed by the Steering Committee which may offer its own suggestions.

At the December meeting there will be a chance to ask questions and to comment on the suggested budget. The Reps may then take the draft back to their groups for further review and comment.

Come January, we should be ready to make any needed adjustments to the 2014 budget, and have a final vote on it.

LIGHT REFRESHMENTS

Right of Decision

The Twelve Concepts for World Service written by Bill W. suggest the relationship among the various elements of the larger AA service structure. Concept III suggests a "right of decision" for delegated responsibility.

We understand this to mean that our representatives should be trusted to make decisions on our behalf based on their best understanding in the moment of any matter at hand. We do not send them with instructions on how to vote as this would disallow for the value of any discussion on a matter. If we were to expect our representatives to simply carry our groups' instructions, we need not send a representative, but could simply send written instructions.

The decision making process of an informed group conscience is thus dynamic, and is achieved "through the sharing of full information, individual points of view, and the practice of AA principles. To be fully informed requires a willingness to listen to minority opinions with an open mind." (*The AA Group*, p. 28.)

Right of Representation

Under Article III of the Nassau Intergroup (NI) By-laws, every AA group in the county is entitled to representation, a voice and a vote at NI meetings.

Group representatives are not self-appointed, but are selected by their groups. While every AA member is entitled to have their voice heard at NI meetings, when it comes time to vote, only a single member is entitled to vote representing each group. The principle observed is one group one vote, one Rep one vote (Article V, Sec. 4).

As a practical matter, while a member may speak representing more than one group, they cannot vote representing more than one group. It is best if each group has its own Rep.
