### **The Group Conscience**

Tradition Two reminds me that, "For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience." The group conscience is both patient and thoughtful. It takes its time to consider information and individual points of view before expressing itself, hence the expression "an informed group conscience." The effectiveness of this approach to group decision making I think is grounded in my faith in Steps Two and Three where I come to believe in a Power greater myself, and then turn my will and my life over to the care of that Power.

However, having my own point of view on most matters and no doubt holding on to at least some arrogance, I sometimes find it difficult to accept a group decision which does not align with my own views, particularly when I feel strongly about a matter. I want to direct the show and think you should let me. I'm guessing I'm not alone in this.

It seems to be a part of the challenge of living in recovery that I need to be satisfied to be allowed to step up and have my say as a group member, and then step back and accept the outcome of our decision making process in matters large or small.

Perhaps it is my ability to fall one way or the other on this that draws the sometimes fine line between "elder statesman" and "bleeding deacon."

Am I willing to disregard the group conscience when it does not conform to my own, or am I able to accept with humility sometimes being the minority voice which may or may not carry the day?
