Nassau Intergroup (NI) has been publishing a newsletter for many years. It serves as a tool to help the Intergroup reach as many groups, individual members and AAinterested others in Nassau County and beyond as possible, and is available both in a printed edition and an anonymity protected web edition.



As with all things NI does, the newsletter is in service to the Fellowship of Alcoholics Anonymous in the spirit of our Twelfth Step and Fifth Tradition which remind us of the need to carry AA's message of recovery to the alcoholic who still suffers.

The newsletter provides a channel for communication among those interested in AA in Nassau. A typical edition includes a calendar of upcoming service events, information about changes to AA meetings in the county, and announcements of special events such as group anniversaries and workshops. It also carries articles offering the experience, strength and hope of members living AA's Three Legacies: Recovery, Unity and Service. As such, the newsletter is not a only for those in service with NI's Steering Committee (the elected officers and appointed Standing Committee chairs), but for any member with something to share.

I tried to help alcoholic Roland H. (who later helped Ebby T.) suggesting that alcoholics needed a spiritual answer to their problem. In a 1961 letter to AA cofounder Bill W., I observed that the alcoholic needed to "walk on a path, which leads to a higher understanding," and I offered the formula for recovery as "spiritus contra spiritum."

#### **Contributions to the AA Service Structure**

In its long form, Tradition Seven suggests, "we view with much concern those AA treasuries which continue, beyond prudent reserves, to accumulate funds for no stated AA purpose." \* Passing funds along beyond the home group to support AA's service structure is one

way to deal with an excess. Individual members too are encouraged to support AA's service structure when they can.

Groups must make their own decisions on whether, when, where and how much to contribute beyond the group's expected need and a reserve.

In considering making contributions, it may be helpful to learn how each service entity uses the money contributed to it. For Nassau Intergroup, the annual budget report and the monthly treasurer's reports provide good information. Similar information should be available from the other service entities.

Also, most of the service groups listed will not pass along contributions you intended for another service group. Please send all contributions directly to the service group you would like to support.

#### **Gift of Desperation**

How can desperation be a gift? For me, desperation and the willingness to accept that I am an alcoholic and that Alcoholics Anonymous was the only chance to become whole, became a gift.

When I admitted defeat from my way of living life, I became willing to accept that alcohol was my biggest problem. I saw the light at the end of a tunnel that had become pitched black. I walked into the rooms of Alcoholics Anonymous with hope. My road was not an easy one because I had to accept that "I" was not perfect, that "I" had character defects, that "I" needed to change my attitudes, my way of thinking and accept that I had no control over anyone in my life. I needed to face the fact that I was not unique, I could only be responsible for my actions, and most of all, that if I picked up a drink, I did not stand a chance. I remember seeing and hearing the slogans, the first which hit home for me was "It's the first drink that get you drunk" and "One is too much, 100 is not enough." These two for me especially were "Ahah" moments.

I turned to the GOD of my understanding and have since developed an intimate relationship with him, "Of myself, I am nothing."

I have learned in AA that alcohol is but a symptom of a greater problem: feeling worthless/less than, uncomfortable, uneasy, lonely. Alcohol camouflages these feelings. In AA, I've learned that it is OK to feel, to cry and to eventually let go. (Letting go for me has always been difficult.)

It is over seven years since I came into the rooms of AA, and my life has changed. I know that for me, I need to stay close to AA because I do not want to lose this gift.

I continue to be involved, committed and of service to AA at any and every opportunity that presents itself.


