April 1935— Dr. William Silkworth suggests Bill W. stop preaching at drunks and instead tell them of obsession and allergy.

April 1939 - Bill & Lois W. lose the 182 Clinton Street home.

April 10, 1939— The book Alcoholics Anonymous is published.

April 24, 1940— First pamphlet, AA, published.

April 25, 1951— First General Service Conference held.

April 1958— The word "honest" ("an 'honest' desire to stop drinking") dropped from the "AA Preamble."

April 3, 1960— Fr. Ed Dowling, SJ, dies, Memphis, Tenn.

April 1, 1966— Sr. Ignatia dies, Richfield, Ohio.

April 1973 — Distribution of the "Big Book" reaches one million. One millionth book presented to President Richard Nixon by Dr. Jack Norris, Chair of the General Service Board.

Northeast Regional Forum (NERF)

"Regional Forums originated in 1975 at the suggestion of Dr. Jack Norris, then Chair of the General Service Board of Alcoholics Anonymous. They were to be weekend sharing and informational sessions designed to help the General Service Board, AA World Services, Inc., the Grapevine Corporate Board, the Grapevine Staff, and the General Service Office Staff stay in touch with AA members, trusted servants and newcomers to service throughout the AA service structure."

"There is no registration fee for Regional Forums or Additional Regional Forums. The General Service Board covers the expenses of meeting rooms. In many places, area committees, districts and groups cover or defray the transportation and lodging expenses of the trusted servants representing them at a Forum."

Regional Forums are had every other year in each of the eight AA regions in the US and Canada. This year the Northeast Regional Forum will be held the weekend of May 29 in Albany, NY.

Go for the weekend or go for the day. With a format that includes both formal presentations and informal conversations, NERF offers a chance to speak directly with Trustees. other members of the Board, and staff members from both AAWS and AA Grapevine.

Rules of Order

Rules of Order allow for the orderly and effective running of a business meeting. In brief, they include:

- Main Motion The matter (or question) up for consideration. Should be concise, unambiguous and complete. All motions must be seconded to go to discussion or decision (vote).
- Amendment— A motion to change the main motion.

 Amendments must be germane to the main motion. A so called "Friendly Amendment" makes small changes to a motion with the permission of the maker of the motion while the motion is pending.
- Previous Question (or, Call the Question) A motion to close discussion and to move to a vote on the main motion. [Requires a majority vote.]
- Postpone A motion to defer further consideration of the main motion to a specified later time or meeting.
- Lay on the Table (or, simply Table) A motion to set aside the main motion to allow consideration of more pressing business. Commonly used incorrectly in place of a motion to Postpone.
- Putting the Question (to a vote) Most procedural motions are decided by a simple majority vote; in AA most motions concerning matters of policy (conscience) are decided by a majority vote.

Common courtesy should prevail. Only one member usually speaks at a time directing his/her comments to the chair. Speakers are usually expected to wait to be acknowledged by the chair before speaking.

These should be understood and applied in the context of AA's guiding principles as reflected in our "Steps," "Traditions" and "Concepts."

Too many groups?

Tradition Three reminds us, "Any two or three alcoholics gathered together for sobriety may call themselves an AA group, provided that . . . they have no other affiliation."

Why are new groups started? Some say all that's needed to form an AA group is a resentment and a coffee pot. While this is true on one level, it perhaps falls short of considering what may be best for AA as a whole, the important but often disregarded latter part of Tradition Four, and what may best serve individual recovery.

While the growth in AA membership has remained relatively flat in recent years, there has been growth in the number of groups and meetings. This is certainly true in Nassau. The result is that our groups are becoming smaller. Where there may have been one or two relatively large groups meeting in a given community, now there



may be several smaller ones. Participation at any one meeting may be small even if local groups do not meet on the same days or at the same times. Each group needs to pay rent, buy supplies and literature and perhaps keep insurance. Each needs to handle Twelve Step calls, offer sponsorship to newcomers, field a team of officers and, hopefully, representatives to the service structure. The smaller the participation, the more challenged the group

may be to do these things, the more difficult it

may be for the group to be fully self-supporting and effective. Competition among groups for member participation and member dollars may not be healthy for the Fellowship as a whole.

A group struggling for survival may want to consider merging with another similarly struggling local group. In starting a new group or meeting, consider, is there a real AA-based need in terms of Tradition Five? Do groups already meet in the community or nearby?

On a more personal level, pre-recovery, it was often my approach to challenges in life to move on rather than to stay put and deal with what unsettled me. The lesson for me may be that, if I'm unhappy with my group for whatever reason, the challenge is to stick around, and to try to effect positive change. I may find considerable personal growth in staying the course at home.

A Bit More History—

Bill W. on the Establishment of the General Service Conference as a Formal Pillar of the Third Legacy

The AA General Service Conference began meeting on an experimental basis in April 1951, and became an enduring part of the AA service structure at the Second International Convention in 1955 where it was said, "AA comes of age."

The following is from the Archives of AAWS, Inc. from an unpublished 1954 talk given by AA co-founder Bill W.

So there was a long discussion, in which I had a sad falling out with a good many of my friends, some of whom had been trustees, and it was quite a bitter and harrowing chapter in our affairs, which none of you know about.

This struggle, to see whether this movement would always be headed by a self-perpetuating hierarchy of oldtimers, or whether these affairs, so vital to the welfare of AA all over the world, should be turned over to you.

And finally, after six years of hassling about it, I finally got the consent of the Board of Trustees to come out to you, and to say:

"Here is a means, which in experimental form, we have put in a pamphlet marked 'The Third Legacy.'

"Here is a means by which you can get some delegates and state committeemen, and send folks up to New York, to take charge and to take over what is now your business. This Conference of delegates shall hereafter be the custodians and the guardians of our Traditions.

"And so why don't you come up there and look this deal over, and the trustees will agree to make themselves responsible to you instead of to nobody.

"And you look it over and see what you think about it, and if at the end of four years you like the way that it's temporarily laid out, then we'll drive a plug in this thing, then we oldtimers up there, including yours truly, will say, 'Look folks, these vital services are yours, to have, and to hold.'

"This Conference of delegates shall hereafter be the custodians and the guardians of our Traditions. This is yours. This is the remainder of your Third Legacy. Will you accept it?"

So, since 1951 we have been holding these yearly Conferences, to see whether this movement was interested enough, was responsible enough, felt those services were worthwhile enough, to maintain so long as God will need this society.

And I think it's the conclusion of every delegate who has been there that yes, we should take these things over.

So, in 1955 we purpose to hold an International Convention, at which time, on behalf of the oldtimers, and of Smithy and me, we shall say to you, here is the remainder of your Third Legacy.

The Conference shall become our successor.

To you we hand the last torch. Carry on. Face your destiny with surety and courage, and God love you.

In Remembrance of Johnie J. Long Beach, New York

For the past seven years, I was privileged to enjoy Johnie J.'s company. Johnie was a God loving man, a gentleman, respectful and truly at peace with himself (he loved life). He was a sharp dresser, was never seen without his signature brim hats and always a toothpick hanging from the side of his mouth. He was a man of few words, had a hardy laugh and when he smiled, his entire face lit up.

The two most important things in his life were his sobriety and his family.

I met Mr. Johnie J. seven years ago. I always called him, "Mr. Johnie J." You see, whenever I saw him I would say: "Hello, Mr. Johnie J." and he would answer: "Hello, young lady," and we'd laugh.

I met him at an AA meeting, "New Beginnings" in Long Beach which was his home group and it became mine. For the seven years I knew him, Johnie always sat next to the door and welcomed everyone as they walked in. He would get to our meeting place early to set up the chairs, the literature table and whatever else needed to be done. Johnie always volunteered to help with whatever he could.

Johnie and I came to know each other well. We went on speaking commitments together and many times I would pick him up to go to a meeting or drop him home afterwards. He told me that his sobriety changed his life and gave him back many things he had lost, especially the relationships he cherished with his family. Johnie worked on his sobriety every day. He had a list of people he called and kept in touch with regularly, and I was privileged to be among them. Every holiday, Thanksgiving, Christmas, New Year's, Easter and Mother's Day mornings, Johnie would call me and say, "Hello young lady, Happy Thanksgiving, etc. and may God bless you and your family." I looked forward to these calls; they put a smile on my face. I will miss them dearly.

A month ago I heard that Johnie was in the hospital. I called him and he told me that he had some infection and would be getting out in a couple of days. After that day, it became extremely difficult to reach him. Many of us, his friends were very worried about him. On Sunday, March 8, 2015, again I called his cell phone and was happy that his daughter picked-up. She told me of his condition. I asked her to please keep me informed, that he was in my prayers and she promised to do so. When I hung up, I felt a physical heaviness in my heart. Then I thought to myself, God is calling him home. Monday morning, March 9th, on the train going to work, I saw a missed call from his cell phone stamped 7:20AM, and I knew that Johnie was gone. I called his daughter who told me that he had passed away late Sunday night. I felt sad, Johnie had touched my heart. Walking to work, I thought about all that Johnie meant to me and the moments we shared. He will be missed by so many people. Then, I smiled; a spring came into my step and a warm feeling in my heart. I walked the rest of my way to work with that smile. The Sun started to shine and I pictured Johnie in God's house wearing a white three-piece suit, white shoes and a white brim hat with a gold band and that smile lighting his face.

So I say to you, "Goodbye Mr. Johnie J. Have a blessed life in God's house, until we meet again. You are in good company." Regine V.

New Beginnings Group, Long Beach

NERAASA 2015— Report to Nassau Intergroup

LaRaine A. and I represented Nassau Inter-Group at the annual Northeast Regional AA Service Assembly (NERAASA) Conference in late February. There were just over 900 people in attendance. It was held in Somerset, NJ, an area that's proud to claim it's the "Home of the Big Book!"

NERAASA is a regional gathering designed to discuss issues and concerns affecting AA as a whole. The Northeast Region includes all of New England, New York, New Jersey, Pennsylvania, Delaware, Maryland and Washington, DC. Attendees included volunteers from all levels of service from National, Regional, District and Area General Service positions, and Central Office/Intergroup representatives. I was able to see how AA's "inverted pyramid" organizational structure works.

General Services does a lot of work that is largely invisible to us on the individual group level, such as printing, updating and editing the growing library of AA literature. But they do so much more. They provide the tools for us to carry the message and maintain the platform that allows our Fellowship to grow.

Besides the usual conference speakers and reports, there were interesting and spirited Roundtable discussions concerning outreach, training, literature, corrections, the Hispanic community and young people. Much of the energy over the weekend was devoted to discussions on how we can use the Internet to reach the still suffering alcoholic. It is clear that web sites, chat rooms and social media platforms raise serious challenges to our founding principles and traditions, especially anonymity. It is generally agreed that AA guidelines pertaining to the internet need to be established, but the pre-eminence of the group conscience must always prevail.

Common to all areas of interest is the dedication and commitment of the volunteers. With all that energy and experience at hand and on display at NERAASA, the question then becomes: "What do individual groups want?" That, of course, depends on how each group chooses to be connected to the "chain of communication." It begs the question of how "dark" any group wishes to be in terms of visibility and representation.

Attending the conference highlighted a vast array of services that are available to each one of us on the local, regional and national level. The only requirement for assistance is a desire to participate more deeply. All we need to do is ask for help! There's a whole army of AA's out there who work tirelessly and thanklessly to help other alcoholics. It's fascinating, a miracle really. Some how, some way, a bunch of drunks can get a whole lot accomplished, as long as they don't take that first drink!

Answer to Who Am I?

Fr. Edward Dowling, SJ (1898-1960) first met Bill W. in 1940 at the 24th Street Clubhouse in NYC. Bill, who suffered from depression, was at a low point then. Announced to Bill as "some bum from St. Louis," Fr. Dowling had been reading the newly published book, Alcoholics Anonymous. In reading, he had found what he thought were parallels between AA's Twelve Steps and the Jesuit's Exercises of St. Ignatius, a compilation of meditations, prayers, and contemplative practices developed to open a broader pathway to God and God's will in our daily lives. Bill found Fr. Dowling engaging, and would later characterize that evening as the night he took his 5th Step. From that initial encounter would evolve a 20 year relationship with the man Bill would call his "spiritual sponsor." Fr. Dowling would later be a speaker at the 2nd International Convention in 1955, and would also join Bill in his experimentation with LSD as a tool for spiritual development.
