### **AA'S THREE LEGACIES FOR MARCH**

**Step 3**— Made a decision to turn our will and our lives over to the care of God as we understood Him.

**Tradition 3—** The only requirement for AA membership is a desire to stop drinking.

**Concept 3**— To insure effective leadership, we should endow each element of AA—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."

### **AA HISTORY FOR MARCH**

March 1938— Bill W. begins work on the "Big Book." Works Publishing, Inc. established to support the book's publication.

March 1939— Draft of the "Big Book" is edited down, and a final draft is presented to Cornwall Press for printing.

March 1941— First prison group formed at San Quentin, Calif.

March 1, 1941— First Jack Alexander article in Saturday Evening Post boosts awareness of AA and AA membership.

March 10, 1946— NY Intergroup formed.

March 29, 1950 — Second Jack Alexander Saturday Evening Post article on AA published, "The Drunkard's Best Friend."

March 22, 1951 - Dr. William D. Silkworth dies, Towns Hospital,

March 1952— Al-Anon Family Groups is founded.

March 21, 1966— Ebby T. (Bill W.'s sponsor) dies, Ballston Spa,

March 1992— The AA General Service Office moves to 475 Riverside Drive, NYC.

"Practicing Step Three is like the opening of a door which to all appearances is still closed and locked. All we need is a key, and the decision to swing the door open. There is only one key, and it is called willingness." —From Step 3, Twelve Steps and Twelve Traditions, p. 34.

### Who Am I?

I met AA co-founder Bill W. on one of his admissions to Towns Hospital, and at one point discussed with Lois W. his possible institutionalization. When he told me about his "white light" experience, I replied, "Something has happened to you I don't understand. But you had better hang on to it. Anything is better than the way you were." In the "Big Book," I described alcoholics as being "restless, irritable and discontented." An early booster of AA, I remained a lifelong friend to the Fellowship. (Answer, p. 6.)

### FAQs About AA History from AAWS \*

**Q.**— Who are the recipients of the milestone printing copies of the Big Book?

A.— The one-millionth copy was presented to President Richard Nixon in April 1973, and the two-millionth to Joseph Califano, Secretary of Health, Education and Welfare, in June 1979. At the 50<sup>th</sup> Anniversary International Convention in Montréal in 1985, the five-millionth copy of the Big Book was presented to Ruth Hock, who typed draft after draft of the original manuscript. The ten-millionth was presented to Nell Wing, Bill W.'s longtime (nonalcoholic) secretary and AA's first archivist, in July 1990. The 15-millionth was given to Ellie Norris, widow of former trustee chairman John L. Norris, MD, in 1996; and in the year 2000, the 20-millionth copy was presented to the Al-Anon Family Groups. The 25-millionth copy was presented to Jill Brown, warden of San Quentin Prison, in July 2005, at the AA International Convention in Toronto.



### Answer to Who Am I?

William D. Silkworth, MD (1873-1951)— A graduate of Princeton University, Dr. Silkworth earned his medical degree at New York University, and interned at Bellevue Hospital where he began to develop what would become an affinity for working with alcoholics. He served at the US Army Hospital in Plattsburg, NY during WWI, and later worked at the Neurological Institute of Presbyterian Hospital. After suffering significant losses in the stock market crash of 1929, the

doctor accepted a job as Medical Director at the Charles B. Towns Hospital for Drug and Alcohol Addictions in New York. It was there in 1933 that Dr. Silkworth met Bill W., a returning patient. It was from him that Bill learned of the true nature of his problem, that he suffered from a mental obsession with and a physical allergy to alcohol, not a moral failing as was the common view of alcoholism at the time, but a true disease. (It may have been this view of alcoholism as a disease which would later in part help Bill connect with Dr. Bob when they first met on Mother's Day, 1935.) It was to Silkworth that Bill reached out after his "white light" experience in Towns during his last admission there to be assured of his sanity. The doctor validated Bill's experience, and encouraged him to hold on to it. Silkworth would encourage Bill as he reached out with little success to fellow sufferers to first emphasize the hopeless nature of the alcoholic's condition, rather than his spiritual awakening which might be off putting at the outset of a contact. A consultant on the drafting of the "Big Book," Dr. Silkworth is the author of "The Doctor's Opinion" which essentially opens Alcoholics Anonymous. (The original of the letter in that writing is below.) Referred to by Bill W. as "a founder of AA," Dr. Silkworth would go on to be one of medicine's early supporters of AA (he was



in attendance at the early meetings with the Rockefeller associates, and authored the first medical paper written about AA which appeared in 1939), and a lifelong friend to the Fellowship. (See, *Alcoholics Anonymous*, pp. xxv-xxxii and 14; *Alcoholics Anonymous Comes of Age*, pp. 13, 143, 148, 160, 168,

183 and 302-308; and, *Pass It On*, pp. 99, 101-104, 108-109, 123, 133, 143, 184-185, 200, 233 and 388.)
