### Literature

April 10 is the 78th anniversary of the publication of the book Alcoholics Anonymous (B-1). The book is now in its fourth edition, and while the basic text has remained essentially unchanged, the stories section has evolved with each edition to include stories more reflective of the face of the membership at the time. This means that a number of stories have been retired with each new edition. Those 56 retired stories are collected and offered in the anthology *Experience, Strength & Hope* (B-20).

Bill W. wrote, "The story section of the Big Book is far more important than most of us think. It is our principal means of identifying with the reader outside of AA; it is the written equivalent of hearing speakers at an AA meeting; it is our show window of results." He continues, "The main purpose of the revision is to bring the story section up to date, to portray more adequately a cross section of those who have found help—the audience for the book is people who are coming to Alcoholics Anonymous now." Many of the removed stories were written in what is referred to by some as the "flying blind" period, the time before the development and adoption of AA's Twelve Traditions, before AA meetings became ubiquitous, and before many other AA-based resources (such as local Intergroup associations, service literature, and easy access to AA) existed. Yet, in each, the message of recovery and the language of the heart are clear.



Check out, *Experience, Strength & Hope.* Are you familiar with the *AA Guidelines*, a collection of short publications out of the GSO on a variety of topics such as Archives, Finance and the Internet for AA? They offer shared experience from around the Fellowship on these and 14 more topics, and are available for free download at www.aa.org. (Go to, "<u>AA Literature</u>," > "AA Guidelines," or search under, "Guidelines.")

Did you know this year's General Service Conference is considering retiring the pamphlets; *Three Talks to Medical Societies by Bill W. (P-6) and Too Young (P-37)*, making revisions to several others, and possibly developing literature concerning safety in AA? Ask your group's GSR if you'd like to know more.

Next month we'll take a look at the *Group Handbook* (M-36), a collection of AA materials offered together in a binder designed to assist AA groups as they form and work to carry the message of recovery through AA.

# STEP FOUR "Made a searching and fearless moral inventory of ourselves."

In Step 4 we continue our self-discovery by taking a careful and in-depth look at ourselves. We focus on our resentments, fears, and harms done to others, which contributed to our compulsive behaviors. At first, this Step may seem overwhelming. Feelings of guilt, shame, remorse, confusion and hurt are very common. When we carry around guilt and anger, sometimes we can't even bear the thought of reviewing our past. It is too painful to think about those we hurt and how we've hurt ourselves. Sometimes we may even question re-opening these old wounds. If it were up to me, it would have been easier to forget the past and move on. Right? This is why we go through the Steps, especially Step 4, with the guidance of a sponsor or spiritual advisor. So, how was I to take a "searching and fearless" look at myself? There were lots of feelings that came up in the very beginning. With a little guidance, I got over the fear and anxiety of taking Step 4. I began to put pen to paper. I was constantly reminded that Step 4 wasn't just about my past, but instead it was about getting to know myself better. We write our inventory to discover the truth about the lie.

An inventory becomes a ritual housecleaning. We sort through our lives looking for unwanted, outdated clutter, taking up space. It is only then, that we can make room for something new. When our inner houses are clean and clear, our higher power can guide our thoughts and actions.

# Tradition Four "Each group should be autonomous except in matters affecting other groups or A.A. as a whole."

Autonomous: a. self-governing; independent; subject to its own laws only. b. pertaining to an autonomy, or a selfgoverning community.

This tradition means that "we had been given the courage to declare each A.A. group an individual entity, strictly reliant on its own conscience as a guide to action." (Twelve Steps and Twelve Traditions, p. 147.) When our forefathers were charting this freedom, they found it necessary to post only two red flags: A group ought not do anything, which would greatly injure A.A. as a whole, nor should it affiliate itself with anything or anybody else. "There would be real danger should we commence to call some groups 'wet,' others 'dry,' still others 'Republican' or 'Communist,' and yet others 'Catholic' or 'Protestant.' The A.A. group would have to stick to its course or be hopelessly lost. Sobriety had to be its sole objective. In all other respects there was perfect freedom of will and action" (Twelve Steps and Twelve Traditions, p. 147) and to develop itself as it sees fit, so long as the main goal was sobriety, and no other A.A groups were affected.

For example, an AA group may declare itself as Special interest group according to a group conscious, perhaps LGBTQ friendly. However, Tradition 3 must remain intact.

Another example: My old home group wanted to change the anniversary celebration times. When taking a vote to establish the new group conscience, someone explained that the new celebration time would interfere with a neighboring group's celebration. So as to not conflict, or affect the neighboring group, our group decided not to make the change.

These examples are at the core of Tradition 4.

My understanding of this Concept says that all groups within AA should be given a right to participate in the affairs of AA (e.g., Delegate's Questionnaire). It also provides for the staff of non-alcoholics, that they should be permitted a right to vote in proportion to the responsibility they hold. This makes sure that all responsible components needed to make knowledgeable decision, have the right to participate and provides vocalization for the people with the knowledge of how things operate on a daily basis.

### **NIAA Institutions Committee**

Occasionally, AA members will ask what's involved in institutions work, so it might be of value to describe this work and its components. The first installment (chairperson) was in January's newsletter. In February the responsibilities of speakers at meetings held in institutions were explained. Last month, we reviewed the institutions committee of NIAA. This month, we'll review the institutions that Nassau Intergroup supports. Although hospitals in Nassau County make up the majority of the institutions we support, we work closely with the NIAA Corrections Committee (in fact, the corrections committee meeting immediately follows the institutions meeting each month). Here is an abbreviated list of the institutions supported by the committee, along with the town and number of meetings held per week (the complete list, along with days/times of the meetings can be found in the back of the NIAA meeting list):

- Brunswick Hospital, Amityville, 3 meetings/week
- Hempstead Park Nursing Home, Hempstead, 1 meeting/week
- Melillo Center for Mental Health, Glen Cove, 2 meetings/week
- Nassau County Correctional Center (Jail, DART), East Meadow, 10 meetings/week
- New Hope and Primary Care Program Treatment Center, Freeport, 2 meetings/week
- Northport VA, Northport, 3 meetings/week
- NUMC, East Meadow, 10 meetings/week
- Salvation Army, Hempstead, 1 meeting/week
- South Oaks (NS LIJ) Amityville 8 meetings/week
- Zucker Hillside Hospital Glen Oaks 1 meeting/week

The founders of AA were visionaries, particularly in their characterization of alcoholism as a disease. This was a revolutionary idea at the time – rather than the prevailing view that alcoholics were simply bad people, the perception was transformed to the modern view that alcoholics are gravely ill people – and people who can get well. As you probably know, the NIAA Institutions Committee brings AA meetings into institutions throughout the county (it is the longest standing committee of NIAA). (Continued above)

The goal of the committee is a simple one, and in support of our primary purpose: we try to make sure that whenever someone in a detox, a rehab or a psych ward reaches out for help, the hand of AA is there. Beyond that, while these institutions provide treatment for the acute symptoms of the disease of alcoholism, we can provide the information and introduction to the broader AA community necessary to get well, and stay well.
