AA's Three Legacies for May

Step 5 – "Admitted to God, to ourselves, and to another human being the exact nature of our wrongs."

Tradition 5 – "Each group has but one primary purpose—to carry its message to the alcoholic that still suffers."

Concept 5 – "Throughout our world service structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that minority opinion will be heard and that petitions for redress of personal grievances will be carefully considered."

STEP FIVE - "Admitted to God, to ourselves, and to another human being the exact nature of our wrongs."

In the 5th Step we turn our 4th Step inventory over to another person discussing our shortcomings and admitting our wrong doings out loud. It is important to choose an understanding and trustworthy person such as a sponsor, close friend/family member, or clergy member.

"No defect can be corrected unless we clearly see what it is." (Twelve Steps and Twelve Traditions, pg. 58)

For me it was not until I wrote out a thorough 4th Step, sat down with my sponsor, and spoke about every skeleton in my closet. I didn't have to carry these burdens around anymore. I didn't feel the need to isolate anymore. For the first time I felt as if I was among people who understood me. I could share my wrongs and maybe someone could identify. The point is that I wasn't alone.

The whole experience was extremely humbling and eye opening. Taking Step 5 is the key to long-term sobriety.

CONCEPT FIVE – "Throughout our structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered."

This concept reminds us that the well heard minority is our chief protection against an uninformed, misinformed, hasty or angry majority. Equally important is the guarantee to any individual in our service structure, the right to petition for redress of a personal grievance, going directly to the General Service Board if necessary. These principles of Appeal and Petition demonstrate, once again, the emphasis placed on our Legacy of Unity, so necessary for our survival.

I have personally seen this concept in action at different levels in our structure and it leaves one with a great level of respect for all points of view even if they don't prevail. I have seen the minority view prevail and be accepted by all involved. An issue of group conscience had been voted on by my Home Group. As is our practice, minority opinion was requested and a group elder stated her case for an opposing view. A new vote was held and the majority changed the vote. We realized that we had not thought things all the way through and our willingness to listen and reflect allowed us to correct our original hasty decision.

It should also be remembered that these concepts were the result of 27 years of experience and were not adopted by the General Service Conference until April 26, 1962. Also important is the fact that these concepts can be amended if necessary through execution of our democratic process. Indeed, the checks and balances built into our governing documents, especially Concept V, help us avoid unqualified authority from running unrestrained.

NIAA Institutions Committee

Occasionally, AA members will ask what's involved in institutions work, so it might be of value to describe this work and its components. The first installment (chairperson) was in January's newsletter. In February the responsibilities of speakers at meetings held in institutions were explained. In March, we reviewed the institutions committee of NIAA. Last month, we did an overview of all the institutions that Nassau Intergroup supports. Starting this month, we'll review each of the institutions that Nassau Intergroup supports. We'll cover them alphabetically, so we'll begin with Brunswick Hospital, located at 1 Louden Ave Amityville, New York 11701. Three meetings a week are held in the Building 11(main building) basement conference room, on Mondays, Wednesdays and Fridays at 7:45P. Their website is https://www.brunswickhospitalcenter.org/ and the following description is taken from there.

Brunswick Hall at Brunswick Hospital Center is a 124-bed private acute care psychiatric hospital licensed by the New York State Office of Mental Health and accredited by The Joint Commission and Centers for Medicare & Medicaid Services. The treatment program is described as follows:

The Adult program features individualized care that incorporates the patient's goals in treatment planning and involves the patient as a participant on the treatment team. In addition to medications, treatments usually include individual and group psychotherapy and/or AA and NA meetings for those with an underlying component of chemical and substance dependency.

The founders of AA were visionaries, particularly in their characterization of alcoholism as a disease. This was a revolutionary idea at the time – rather than the prevailing view that alcoholics were simply bad people, the perception was transformed to the modern view that alcoholics are gravely ill people – and people who can get well. As you probably know, the NIAA Institutions Committee brings AA meetings into institutions throughout the county(it is the longest standing committee of NIAA). As you probably also know, these days most of us find our way to AA through an institution of some sort. The goal of the committee is a simple one, and in support of our primary purpose: we try to make sure that whenever someone in a detox, rehab or psych ward reaches out for help, the hand of AA is there. Beyond that, while these institutions provide treatment for the acute symptoms of the disease of alcoholism, we can provide the information and introduction to the broader AA community necessary to get well, and stay well. If you think you might be interested in supporting this kind of service, or would like to learn more about it, or if you know of an institution interested in having AA meetings, please attend the meetings of the Institutions Committee held the first Wednesday of each month at 8P at the Simpson Methodist Church 30 Locust Av Amityville, which is right across Sunrise Highway from South Oaks Hospital. Literature

"Most of us cannot recover unless there is a group. As Bill said, 'Realization dawns on each member that he is but a small part of a greater whole He learns that the clamor of desires and ambitions within him must be silenced whenever these could damage the group. It becomes plain that the group must survive or the individual will not.' " [From, The AA Group (P-16), p. 11.] So begins the letter to the group found in the *Group Handbook* (M-36).

The *Group Handbook* is a collection of AA materials offered together in a binder designed to assist AA groups as they form and work to carry the message of recovery through AA. It includes a collection of service materials, a GSR Kit, select *AA Guidelines*, a large selection of AA pamphlets, a local *Regional Directory* (for us, MD-4), a current copy of *Box 4-5-9* (GSO's newsletter), an AAWS literature catalogue, and a goodly number of other items selected to help groups.

Interested? A listing of the handbook's contents is available through the Intergroup office.

Were you at Share-A-Day last month? If so, you may have visited the Literature table and enjoyed the presentation of the "Big Book" on DVD (DV-11) closed captioned in American Sign Language (ASL) for the deaf and hearing-impaired, or the presentation of *Bill's Own Story* (DV-04), just two of the many audio-visual items available from AAWS. You also may have noticed the literature rack filled with some of the many free items available from AAWS, and the small display of copies of the "Big Book" published in other languages. (The "Big Book" is now published in 49 other languages and in Braille.) For more, check out the newly released AAWS literature catalogue, *Alcoholics Anonymous Conference-Approved Literature and Other AA Material, 2017* (F-10), available free through Intergroup or from AAWS.

Next month we'll talk about some of the kits available from AAWS to help service committees such as Public Information and Corrections as they work to carry the AA message. Next month too we'll learn from our area delegate what actions if any the 67th General Service Conference took on the several literature-related items before it.
