Literature



The wealth of AA's collected experience with its Three Legacies: Recovery, Unity and Service, is reflected in its literature.

Concerning Service, while this can simply be making coffee, setting out chairs or offering sponsorship at your group, it also includes a wide range of activities beyond. To support our more structured service efforts beyond the home group, AAWS offers kits and workbooks in the main areas of service activity. Each kit collects under one cover suggestions for effective service drawn from Fellowship experience.

Looking at the *Public Information Workbook* (M-27I) as an example, it provides suggestions for forming a PI committee, possible PI workshop formats, approaches to the public media including a discussion of anonymity and PSAs, form outreach letters, sample announcements, and a sample PI presentation outline among considerable other information. The corresponding *PI Kit* (M-27) includes under one cover the workbook along with select pamphlets and *AA Guidelines*, a literature catalogue (F-10) and order forms, and additional service materials from GSO.

Similar workbooks and kits are available for Accessibilities (what we also call Special Needs), Cooperation with the Professional Community (CPC), Corrections, and Treatment (formerly Treatment Facilities, what we call Institutions or H&I). NI offers a complete library of these kits for your information and support. Check with an Intergroup officer if you'd like to access the library.

Next month we'll begin to look at some of the rich offerings from the AA Grapevine. There's a lot more than the monthly magazine.

AA's Three Legacies for June

Step Six – "Were entirely ready to have God remove all these defects of character."

Tradition Six – "An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property and prestige divert us from our primary purpose."

Concept Six – "On behalf of A.A. as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognizes that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous."

Step Six

"Were entirely ready to have God remove all these defect of character."

"He goes on to explain that any person capable of enough willingness to try repeatedly step six on all his faults---without any reservations whatever---has indeed come a long way spiritually, and is therefore entitled to be called a man who is sincerely trying to grow in the image and likeness of his own creator." (pg. 63 Twelve Steps and Twelve Traditions)

From The Night Book: Sponsors: We need your help!

Summer is finally here in full-bloom, and

so is our Hotline Service. From the looks of it, our little Night Book "thing" we have going on here in Nassau has taken the lead in group service commitments; and that's how it should be. As of now, we have a steady lineup of eager groups right up until August 18th! To me, it means that good sponsorship runs rampant throughout our groups. Yes, a sponsor is supposed to be the one person who you turn to for advice on a whole host of issues relating to your sobriety: working the 12-Steps, the 12-Traditions and the 12-Concepts too!-THE TWELVE WHAAAT? Most importantly, a sponsor should be teaching by his or her own example about doing service, both inside and outside of the home group. This is where our Night Book comes in. When an AA has at least one year of continuous sobriety, they are eligible to handle the Hotline at night. The Intergroup Rep will hold up a sign up sheet and make the call for seven people from the group to take the phones from 5:00pm to 9:00am the next morning.

At this point, a good sponsor will talk about it to his or her sponsee. He or she will say that this service is deeply rooted in our Fifth Tradition-carrying the message to the still sick and suffering alcoholic; our main reason for existence as a Fellowship.

More than any service commitment on the planet, doing Night Book works wonders on the volunteer's sobriety as well as helping the caller out. It isn't just groups. I get calls and messages all the time from solo AA's who just want to be on a "stand-by list" to take the phones in the event of a situation where the scheduled volunteer cannot do it. The sponsor should encourage this as well. (Continued page 5)

NIAA Institutions Committee

Occasionally, AA members will ask what's involved in institutions work, so it might be of value to describe this work and its components. The first installment (chairperson) was in January's newsletter. In February the responsibilities of speakers at meetings held in institutions were explained. In March, we reviewed the institutions committee of NIAA. In April, we did an overview of all the institutions that Nassau Intergroup supports. We're now reviewing each of the institutions that Nassau Intergroup supports, covering them alphabetically, and we are now up to the Hempstead Park Nursing Home, located at 800 Front St, Hempstead, NY 11550. One meeting a week is held in the Sunshine room on Tuesdays at 6:30P (supported by the North Bellmore Group). Patients who are AA members, or who may have a problem with alcohol, are invited to attend. The patients at the Hospital look forward to the weekly meetings, especially hearing a speaker sharing their words of encouragement. These weekly meeting are the only source they have of interacting with other alcoholics. Most are not allowed or are not capable to attend outside meetings. You can see how important it is that we bring meetings to them and share words of encouragement. The institution does not have a website so the following information is taken from the NYS Dept. of Health website https://profiles.health.ny.gov/nursing_home/view/150448.

It is a 251 bed nursing home facility providing nursing, clinical laboratory and radiology/diagnostic services.

The institution can be contacted at (516) 705-9700. The patients at the Hospital look forward to the weekly meetings, especially hearing a speaker sharing their words of encouragement. These weekly meeting are the only source they have of interacting with other alcoholics. Most are not allowed or are not capable to attend outside meetings. You can see how important it is that we bring meetings to them and share words of encouragement. The founders of AA were visionaries, particularly in their characterization of alcoholism as a disease. This was a revolutionary idea at the time - rather than the prevailing view that alcoholics were simply bad people, the perception was transformed to the modern view that alcoholics are gravely ill people - and people who can get well. As you probably know, the NIAA Institutions Committee brings AA meetings into institutions throughout the county (it is the longest standing committee of NIAA). As you probably also know, these days most of us find our way to AA through an institution of some sort. The goal of the committee is a simple one, and in support of our primary purpose: we try to make sure that whenever someone in a detox, rehab or psych ward reaches out for help, the hand of AA is there. Beyond that, while these institutions provide treatment for the acute symptoms of the disease of alcoholism, we can provide the information and introduction to the broader AA community necessary to get well, and stay well. If you think you might be interested in supporting this kind of service, or would like to learn more about it, or if you know of an institution interested in having AA meetings, please attend the meetings of the Institutions Committee held the first Wednesday of each month at 8P at the Simpson Methodist Church 30 Locust Av Amityville, which is right across Sunrise Highway from South Oaks Hospital. Tradition Six

"An A.A. group ought never endorse, finance or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property and prestige divert us from our primary purpose."

The message in this tradition is AA's pledge to remain poor. AA is the leader of "corporate poverty." Money, property and prestige cannot, and should not be the primary purpose of an AA group. Just see tradition 5!

Having too much money, property and power can be dangerous territory for alcoholics and AA as a whole. It is said that we need just enough money to cover our expenses and have a prudent reserve for emergencies. Any more than that can become a nuisance, especially when you have a group of alcoholics arguing over how it should be spent!

We need to divide the material from the spiritual. AA needs to remain poor for our own good. It would be too risky to organize with outside enterprises. Why? Finances would take us away from our primary purpose.

"Nowadays, the A.A. group answers its well-wishers saying, 'Our expenses are trifling. As good earners, we can easily pay them. As we neither need nor want money, why risk its hazards? We'd rather stay poor. Thanks just the same!' "Bill W. The A.A. Grapevine, May, 1948
