# AA's Three Legacies for July

**Concept Seven-** "The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A. A. purse for its final effectiveness."

# "The Only Copy of the "Big Book"

This month Nassau Intergroup hosts its annual picnic in Eisenhower Park. On that occasion Alcoholics Anonymous will be on public display, each of us participating becoming perhaps the only copy of the "Big Book" a given member of the public may see. (Everyone around us may not know who we are, but many certainly will.) Any consideration or courtesy we show other users of the park, our respect for the park itself including how clean we leave the grounds when we go, will reflect on AA as a whole. Similarly, any misbehavior, any foul language we may use, not removing our cars from the grass when asked to, any trash we may leave behind when we go, will also reflect on all of AA.

Please keep this in mind as you enjoy yourself at our picnic. If we each mind our behavior and police our space before we leave (if you brought it in, either bring it out or place it in a proper trash receptacle when you leave), AA will be well represented.

The same holds true for how we handle ourselves in and around our local meeting places. I've been on hand as members cursed up a storm within earshot of a Rectory bedroom window, disturbed church neighbors, and when we left a trail of cigarette butts or coffee cups to mark our comings and goings. Groups have been asked to leave their meeting spaces, even after many years in a location, because of similar problem behavior. (Continued p. 4)

# Tradition Seven

"Every A.A. group ought to be fully self-supporting, declining outside contributions."

I know that before I got sober, I spent money frivolously. I spent money that I didn't have and borrowed money that I never intended on giving back. I also stole money from those I cared about. Not because I didn't love them or wanted to deliberately cause pain, but because I was an alcoholic and needed not only alcohol, but material things in excess. I've heard my story regarding money countless times in AA meetings. After I got sober, I learned how to become "selfsupporting." I obviously didn't need money for alcohol, but managing other excesses became a focus; spending only what I had, limiting my credit card use, and buying things I needed rather than what I wanted. As I got sober and more sober, I was able to treat myself to things that I wanted. So I can only imagine why AA's founding fathers wrote this Tradition. Imagine many alcoholics trying to manage large donations. For all of us to stay sober and to maintain a path to our primary purpose, AA must remain poor.

"Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority." (Twelve Steps and Twelve Traditions, p. 191)

"On behalf of A.A. as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting matters of general policy and finance. But the Conference also recognizes that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous."

And so, just as the groups delegate responsibility to the Conference, the Conference further delegates responsibility to the Trustees. It is in Concept VI that we address the real need for giving the Trustees the authority they need to operate A.A. World Services, Inc. and A.A. Grapevine, Inc. Who are these Trustees to whom we grant all of this authority and legal responsibility? There are presently 21 Trustees, 7 non-alcoholic (Class A) and 14 alcoholic (Class B). They are elected by the General Service Board. While there are no hard fast qualifications, Class A Trustees are men and women with a proven track record in their field, a demonstrated interest in A.A., some experience working with A.A. and its members and a willingness to serve. Class B Regional and at-large Trustees should have 10 years continuous sobriety (not mandatory) and general service Trustees 7 years continuous sobriety. In addition they should be thoroughly familiar with A.A.'s structure, from the group to the Area and the Board and the Conference. They should also know A.A. history and be familiar with the trends that affect our future.

From our humble beginnings there have been nonalcoholic friends and alcoholics who have taken on service commitments to "pass it on". This has evolved over time into our current structure with great trial and error and experience gained resulting in what can only be called a success as we celebrate our 82<sup>nd</sup> anniversary on June 10, 2017. The next opportunity to see our Trustees in action will be in Cromwell, CT on February 23-25, 2018 at the Northeast Regional AA Service Assembly (NERAASA) where the Northeast Region Trustee's report will be delivered as well as panels and roundtables discussing topics related to our structure and our future. #### **NIAA Institutions Committee**

Occasionally, AA members will ask what's involved in institutions work, so it might be of value to describe this work and its components. The first installment (chairperson) was in January's newsletter. In February the responsibilities of speakers at meetings held in institutions were explained. In March, we reviewed the institutions committee of NIAA. In April, we did an overview of all the institutions that Nassau Intergroup supports. We're now reviewing each of the institutions that Nassau Intergroup supports, covering them alphabetically, and we are now up to the Melillo Center for Mental Health in Glen Cove (the following information was provided by Nicole M. DelGiudice, LCSW, ACSW, Director Outpatient Services, Melillo Center, 113 Glen Cove Avenue, Glen Cove, NY 11542, ndelgiudice@melillo.org, and taken from their website). It is a non-profit organization licensed by the NYS Office of Mental Health (OMH) and Office of Alcoholism and Substance Abuse Services (OASAS). Melillo Center offers comprehensive outpatient services to individuals, families and significant others who have been affected by substance use. They are dedicated to providing a safe, caring and therapeutic environment in which to recover. Their supportive and structured, evidenced-based approach assists individuals in abstaining from substances, alleviating symptoms, regaining confidence in order to stabilize and achieve greater levels of functioning.

This was a revolutionary idea at the time - rather than the prevailing view that alcoholics were simply bad people, the perception was transformed to the modern view that alcoholics are gravely ill people – and people who can get well. As you probably know, the NIAA Institutions Committee brings AA meetings into institutions throughout the county (it is the longest standing committee of NIAA). As you probably also know, these days most of us find our way to AA through an institution of some sort. The goal of the committee is a simple one, and in support of our primary purpose: we try to make sure that whenever someone in a detox, rehab or psych ward reaches out for help, the hand of AA is there. Beyond that, while these institutions provide treatment for the acute symptoms of the disease of alcoholism, we can provide the information and introduction to the broader AA community necessary to get well, and stay well. If you think you might be interested in supporting this kind of service, or would like to learn more about it, or if you know of an institution interested in having AA meetings, please attend the meetings of the Institutions Committee held the first Wednesday of each month at 8P at the Simpson Methodist Church 30 Locust Av Amityville, which is right across Sunrise Highway from South Oaks Hospital. But it doesn't just reflect on those individuals or those meetings or groups. It reflects on AA as a whole because non-AAs do not distinguish between individual members—who we understand may still have recovery work to do or our groups, or the fellowship as a whole or program of AA. We reflect our principles in action or we do not. How AA is seen publicly impacts our ability to help the drunk who still suffers.

Hope this is helpful.

# Public Information Committee

### WHAT DOES THE PUBLIC INFORMATION (PI) COMMITTEE DO?

<u>PURPOSE</u> Like all of A.A., the primary purpose of members involved with public information service is to carry the A.A. message to the alcoholic who still suffers. Working together, members of local Public Information committees convey A.A. information to the general public, including the media.

<u>HISTORY</u> The 1939 publication of our Big Book, Alcoholics Anonymous, was the first A.A. information available for the public. By 1941, several articles on A.A. in national publications helped to encourage understanding and acceptance of A.A.

<u>TODAY</u> Our primary purpose has not changed in carrying the message to the alcoholic that still suffers. Working with Cooperation with the Professional Community (CPC) we have been able to carry the message to many different venues, a few of which are listed below.

# <u>Literature</u>

Most members are familiar with the *AA Grapevine* magazine. Offered since June 1944 (and its companion Spanish language publication, *La Viña*, since 1995), the *Grapevine* is often referred to as "our meeting in print." *Grapevine* "is the international journal of Alcoholics Anonymous. Written, edited, illustrated, and read by AA members and others interested in the AA program of recovery from alcoholism, the *Grapevine* is a lifeline linking one alcoholic to another." (From, www.aagrapevine.org/content/about-us.) *Grapevine* brought us the now ubiquitous *AA Preamble*, and was the


brought us the now ubiquitous *AA Preamble*, and was the vehicle Bill W. used beginning in 1946 to introduce us to the Traditions, the "Twelve Points to Assure Our Future" as he called them in his first of several Traditions-related articles, "Twelve Suggested Points for AA Tradition." (See, *Language of the Heart*, pp. 20-24.) AA Grapevine is supported solely through the sale of subscriptions and related items. It does not share in the contributions sent to AAWS/GSO.

I suspect many of us are less familiar with those many other items offered by the AA Grapevine, Inc. which include books and e-books, calendars, tapes, CDs, posters and more.

The most recent addition to the list of 21 other Grapevine books is, *Making Amends: Finding a new freedom.* "*Making Amends* features 55 candid, firsthand stories from AA Grapevine magazine of members' experiences with Step Nine of the AA program. The book includes chapters on making amends to parents, children, family members, exes, financial institutions, friends and coworkers. These powerful stories illustrate how practicing Step Nine can help us, as AA's co-founder Bill W. wrote, 'know a new freedom and a new happiness.'" (From, www.aagrapevine.org/.)
