#### **Step Eight**

When I first looked at the steps and saw Step 8, "Made a list of all persons we had harmed, and became willing to make amends to them all.", I froze in fear. It was explained to me that there are many types of harms we cause to others. In the Twelve Steps & Twelve Traditions they explain 8 types of harms in the 8th Step Essay. This helped me understand more of the harms I had caused others. My list was already started from doing my Harms list, sex inventory and from the 4th column of my resentment list during my 4th step. But the essay helped me to expand upon the list and add more to it that I may have not recognized as harms before as I had more clarity. There's a reason this is a separate step done further in the work.

Now for the fear. I was SO FEARFUL of this step and the one that follows. Make amends to them all?!?! My sponsor at the time had me reread the step over and over. What I failed to see is all it is suggesting I do is become willing to make amends to them all. That didn't mean that I would be making them all but I had to be willing.

This step helps us show compassion by being willing to make right the wrongs we have caused. We hold ourselves accountable and practice humility by admitting exactly what it is that we have done. This step to me was like the ticket booth where you get your ticket to board the boat to freedom. We may not board that boat if we fail to continue with the step work. But if we do, although that ride can be choppy at times, the destination of true freedom is like nothing I have ever experienced.

We attempt to sweep away the debris which has accumulated out of our effort to live on self-will and run the show ourselves. If we haven't the will to do this, we ask until it comes.

#### **Tradition Eight**

Co-founder Bill W., had a first experience with this tradition before it was written.

Bill was asked to work as a counselor at Towns Hospital. Bill & Lois W. were in need of income, for their home was going into foreclosure. Lois is working 2 jobs. Bill has no income. He went home to discuss this offer and one of his friends begun to speak.

The speakers voice grew more confident. "Don't you realize, he went on, that you can never become a professional? We define professionalism as the occupation of counseling alcoholics for fees or hire". One alcoholic talking to another; that's all. Freely received, freely given.

Cleveland, Ohio, was the first service center, known these days as Intergroup Offices. There are hundreds of Intergroup Offices & Hispanic Offices in the U.S. & Canada, some employ special workers.

In a Grapevine article, July 1948, on the Eighth Tradition, Language of the Heart, pg. 88, "We are beginning to see that our few paid workers are performing only those tasks that our volunteers cannot consistently handle. Primarily these folks are not doing Twelfth Step work. They are just making more and better Twelfth Step work possible. Secretaries at their desk are valuable points of contact, information, and public relations. That is what they are paid for, and nothing else. They help carry the good news of A.A. to the outside world and bring our prospects face to face with us".

5. Do I make an effort to understand what AA employees do? What workers in other alcoholism agencies do? Can I distinguish clearly among them?

6. In my own AA life, have I any experiences which illustrate the wisdom of this Tradition?

7. Have I paid enough attention to the book Twelve Steps and Twelve Traditions? To the pamphlet AA Tradition—How It Developed?

#### **Corporate Oversight:**

<u>Authority Divided, Delegated, and</u> (Hopefully!) Unified

Concept VIII continues the discussion of the General Service Board's authority that began in Concept VII. While the previous Concept focused on the relationship between the General Service Board and the Conference, this Concept is concerned with the relationship between the General Service Board and our two corporate entities: A.A. World Services, Inc. (which operates the General Service Office) and A.A. Grapevine, Inc. (which publishes our monthly magazine).

Like many of the Twelve Concepts for World Service, Concept VIII might best be approached by looking at the similarities between how our local Intergroup operates, and how the General Service Board operates.

Many A.A. members in Nassau County are familiar with our local service committees, and the specific areas of responsibility each one assumes. Our Corrections committee, our Public Information committee, and our Office Manager, for example, have very different functions.

And while our Intergroup Steering Committee remains available to provide suggestions and guidance in these service areas and others, it would be a serious mistake to attempt to directly manage the day to day activities, say, of our office volunteers through the mechanism of our monthly Steering Committee meeting. So instead, the Steering Committee tries to stay focused on larger matters of policy and finance, leaving the daily coordination of volunteers in our local office to the trusted servant (currently Kenny!) appointed to manage it.

Similarly, the General Service Board would make quite a mess of things if it tried to manage the day to day operations of the General Service Office and the AA Grapevine/La Vina office from the vantage point of Board meetings held quarterly each year.

So even though the General Service Board has the legal authority to do whatever it wants with our corporate entities, good business sense dictates that the Board practice its oversight by (1) selecting directors to steer each corporation, and (2) delegating daily operations to hired executives (i.e. GSO's General Manager, and AA Grapevine's Publisher).

This delegation of authority is not an abandonment of the GSB's responsibilities, but rather a prudent way of meeting them. By hiring and trusting talented executives (and successful GSO managers and Grapevine Publishers need very different skill sets) the General Service Board is then more able to keep its eye on larger matters of policy and finance. The result is a more unified vision of how best to use our resources of time, money and people -- and thus a more unified effort of the A.A. fellowship.

# **CONCEPT VIII**

The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporated and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities.

#### Staying Sober During a Pandemic

When the pandemic caused everything to close, I was about 2 weeks shy of my 1st anniversary. I started to panic because now I had to isolate. This meant that all A.A. meetings were closed, which scared me. I knew that no meetings plus isolation was a perfect storm for an alcoholic to pick up. Then who knew if there would have been a way back without meetings being accessible.

I had a hard time making phone calls to other A.A. members, as I always have. My sponsor told me about a friend of ours that had started a Zoom meeting. I panicked again because I had no idea what Zoom was. I started to beat myself up because I felt computer illiterate. I also heard there was a number and a password to get into Zoom meetings. I knew that I had two choices, to try or to be miserable. I tried and finally succeeded. WOW! Was I proud of myself. Then I heard that a lot of meetings were going to do their meeting over Zoom.

Eventually, there was access to Zoom meetings all over the world, which I found amazing.

After awhile, Zoom meetings weren't helping me with the lack of being around other people. I was still, in someway, isolated and alone. I even had to celebrate my 1st anniversary on Zoom, with no 1 year coin. I have to say alcoholics (A.A. members) are truly special and amazing because I received coins in the mail from two people. Now I have two 1 year coins. This pink cloud didn't last long, because I was isolating and alone.

The COVID restrictions were to wear a mask and stay 6 feet apart. I started to meet up with friends outdoors, and wearing a mask, while maintaining the proper distance. I started to feel a little better being able to talk to friends and see their face, even with a mask on. I even met up with people in parking lots while staying in our cars and talking. I had to find ways to meet with friends during this difficult time. Through all of this I did a lot of praying and talking to both God and Danny (my deceased husband, I believe that I have two Higher

Powers).

I don't remember the exact month that a friend of mind started a meeting in her backyard. But it felt wonderful to be at an actual live meeting. I was so grateful to her for doing this. I got to meet a lot of other Alcoholics Anonymous members that I have since made friends with. I also went to a recovery center on Friday nights which helped me to be around people, all while following the CDC guidelines.

Staying sober during the COVID pandemic was a tough challenge but my Higher Powers put the help that I needed in my path. I am a grateful recovering alcoholic to be able to stay sober during such a difficult time in everyone's life.

# Please don't throw Zoom away!

As a member of Alcoholics Anonymous I was grateful for Zoom during the Pandemic. It was a life saver for AA. Zoom enabled groups to hold meetings during the past year of isolation.

Now, as the Pandemic ebbs we are able to return to "in person" meetings. Many members and groups are anxious to "go back to the old way".

I'm wondering if we might move forward in a new way including Zoom. Tradition 5 reminds us of our primary purpose – to carry the message to the alcoholic who stills suffers. There are many AA members who are unable to attend "in person" meeting for various reasons that have nothing to do with the Pandemic. Zoom provides a way to reach these AA members.

I can think of a few examples:

Members who physically are unable to get to a "in person" meeting.

Members who travel but would like to attend their home group meeting from afar.

Members who move to a new location but would like to keep their connection with their homegroup as they transition to another community. I think of AA as having a new tool named Zoom.

Let's embrace this new technology and keep it available to the AA member who needs a meeting and is unable to get to one "in person".

When asked what my favorite prayer is what comes to mind is two way prayer or guidance. I'm not sure this is something talked about a lot.

I found two way prayer to be useful in my program. It has transformed my relationship with my Higher Power, whom I choose to call God. For those that are not familiar two way prayer was used by the Oxford group, which is where the twelve steps of Alcoholics Anonymous came from. The Oxford group believed in the four absolutes which are: Honest, Pure, Unselfish and Loving. I've learned through this process, that I can ask God any question and receive an answer.

For example, I can ask God what His will for me is for the day. Then I sit and meditate (which is to listen) and write everything that comes through, I allow God to speak through the pen. After, I check to see if what came through is Honest, Pure, Unselfish and Loving. If it is then I know it's God speaking to me. If I see something that does not meet these four absolutes, then I know somehow, somewhere, I cropped in. In the beginning, only words came through. The more I did this, the more came through. It is a practice, eventually sentences started to come through and from there I've had experiences where my Higher Power spoke to me in the form of a letter. This practice is powerful and profound. That is because my relationship with my Higher Power was growing stronger. Step eleven states "Sought through Prayer and Meditation to improve our conscious contact with God as we understood Him, praying only for the knowledge of His will for us and the Power to carry that out." (Page 59, Alcoholics Anonymous). Prayer is talking

to God, while meditation is listening to God. Sometimes what I think God's will for me is, is not actually God's will.

Through this process, I've found that it helps eliminate me from me and really allows me to be guided by my Higher Power. In the two way prayer process, I get clear cut directions to carry out. It does not matter what I am going through in life, I can always utilize this tool to seek answers. Two way prayer encompasses the 11th step in it's entirety. "...Ask Him in your morning meditation what you can do each day for the man who is still sick. The answers will come, if your own house is in order." (Page 164, Alcoholics Anonymous)

#### CHAIR'S CORNER

#### A life of sane and happy usefulness

An A.A. member recently said "No" when I extended an invitation to serve our local fellowship by taking on a service position at Intergroup.

Can you believe it? An A.A. member was asked to step into a service position, and the member said, quite clearly, "No."

I was incredibly impressed.

And I was even more convinced this person would make an incredible trusted servant. This may sound a bit wonky to some, especially if you've heard and believed one of the things I heard (and believed for a while) when I first got to A.A.

You can probably guess what "suggestion" I'm talking about. The one that says, "Never say 'no' to A.A., since A.A. has never said 'no' to you."

I bought into that idea at first. And because I did, I was soon chairing multiple meetings, serving as GSR for one group, treasurer for another, and I even agreed to be the newsletter editor for our district.

I was neither sane nor happy at this time.

I was often resentful at other members who I judged weren't doing enough. I was frequently exhausted by the constant running around. And I was doing a poor job at most of these jobs simply because I was spread too thin.

Enter a sponsor -- with a degree of sanity, and a better understanding of the "small part" we're invited to play in the "great whole" of A.A.

He suggested I continue/finish with what I'd started, but that I cease volunteering for anything further, and that I begin seeking replacements for anything outside my home group and the one district commitment I'd taken on.

"But what about the suggestion that I never say "no" to A.A.?" I asked.

My sponsor smiled. "Did you turn your life over to A.A.? Or to God?"

"To God."

"Me too. That's why I try to never say "no" to the God of my understanding. But if I'm going to fulfill other God-given roles, like being a husband, a brother, a son, a father, a neighbor, a baseball coach, an employee, or anything else, I'm going to have to say "no" to A.A. at times. The God of my understanding is happy to let me know when, as long as I'm willing to ask."

I was reminded of that conversation from more than a decade ago when the member I mentioned earlier explained the thoughtfulness and prayerfulness behind their decision: the member had brought the invitation into prayer and into an open-minded conversation with a trusted friend, weighing the offer among a number of other responsibilities. And they realized that taking on this new role at this time would ultimately neither benefit our fellowship, nor this particular member and their loved ones.

This member had consulted the only authority for such matters: a loving God that expresses itself through this member's awakened conscience.

It was a lesson in humility, sanity, and usefulness. I am grateful for the reminder. And I'm hopeful that when this member's other responsibilities decrease, they might reconsider the invitation to serve at Intergroup. We need such thoughtful, awakened people.

And with that said, I invite anyone reading this to bring into prayerful contemplation (and open-minded discussion with trusted friends) the fact that we do need more trusted servants at Intergroup -- phone reps, chairpersons for a few service committees, and an assistant treasurer to help with some upcoming events -- and if your Higher Power says you should step up, I'm reachable at <u>chair@nassauny-aa.org</u>.

### Financial Review— Virtual Basket



With so many groups forced by COVID-19 to either shut down or go to a virtual format this past year, many groups had their finances thrown into confusion. Chief among the questions was just how could we continue to practice the principle of self-support suggested in our Tradition Seven under these changed circumstances?

Should we be paying to maintain physical meeting spaces we couldn't use? Could we continue to enjoy the use of storage space in a church basement while we weren't paying rent? How could we pass the basket in a virtual meeting? While group expenses in a virtual world were significantly reduced, they weren't eliminated. How might we pay our way for any resources we needed to field virtual meetings such as a Zoom account? Was it okay for a group member to simply contribute those resources? As our meetings started to return to physical spaces, would we try to keep the digital channels we had opened up with new hybrid meetings (meetings which are simultaneously held face to face and

online)? What about the added expenses attached to running hybrid meetings given the technical and hardware demands for such meetings? What about using member resources such as a hotspot or laptop? Where available, could we use the landlord's resources such as a WiFi connection or hardware? These were just a few of the questions which have come up, and no doubt there are more.

There are no easy answers to many of these questions as many groups have found out, but there is shared experience on some of them including on passing a virtual basket for those meetings which will remain virtual or which will go hybrid.

One useful resource is a piece of service material called "Frequently Asked Questions on Practicing the Seventh Tradition at Virtual Meetings" (SMF-223). (Service material—SM—is a simple sharing of collected Fellowship experience on a given subject in a non-Conference approved document or file from GSO.) This publication helps groups explore their need for a virtual basket, to look at some available resources for setting up a virtual basket, and to consider some of the demands of implementation. (Different approaches have different cost and implementation challenges.) NY Intergroup also has some useful information on this question in its "Guide to Collecting Virtual Seventh Tradition Contributions."

Nassau Intergroup for instance chose to use <u>Zelle</u> for its digital basket, an approach which can also be used to pay for in office literature purchases in place of a credit or debit card. (Feel free to reach out for Intergroup's experience in selecting and setting up this contribution channel.)

Keep in mind there is no endorsement of any resource, service or approach implied. This is all just FYI. Groups need to reach their own conclusions on review of available information, an informed group conscience.

sessions than many of the



- publish and distribute a monthly newsletter.
- provide for quarterly group exchange meetings at which groups may exchange meetings with other groups.
- provide for monthly institutions committee meetings at which groups may arrange to participate in "inside" meetings.
- conduct monthly business meetings to address any group concerns and Intergroup business.
